\* Stretched funded hours may only be taken as set out in the tables above. For non-stretched/term time only hours, see Term Time table.

\* All children who are in receipt of Early Years Entitlement (EEF) funding will be on a stretched offer over 52 weeks which equates to 30hours = 22 hrs per week/15 hours = 11 hrs per week, other than those who are on a term time only contract for 38 weeks per year, which is an option only once they turn 3 years old.

\* When your child celebrates a birthday, they will advance to the next age band the term following their birthday, in line with the funding schedule provided by the local authority.

\* Term time attendance is only available to children aged 3+.

\* Fully funded places are free. If accessing a fully funded place, consumables, meals and enhancements are not available and if food is required, this can be brought into nursery, subject to safe storage and to it not contravening our allergy policy.

\* Unfunded extra sessions above the funded hours are available and are voluntary. Consumables, meals and enhancements are voluntary. Please see provision structure attached for further information.

\* Upon registration and acceptance of a nursery place a £100 non-refundable registration fee is payable for all places, excluding children using a fully funded place.

\* There is no minimum session requirement.

\* Fees are based on 52 weeks of the year, paid monthly in advance.

\* All absences, holidays, bank holidays, sick days and other absences are therefore charged whether or not your child actually attends on these days. (Applicable to funded and non-funded places that are taken together)

\* Four weeks' notice of change or termination of a place is required.

\* Tax Free Childcare or other entitlements may be available, please visit <https://www.beststartinlife.gov.uk> for further information.

\* Childcare providers are able to claim additional funding for those children who are in receipt of Disability Living Allowance (DLA). You will be required to provide a copy of your up to date Disability Living Allowance award letter, in order for your childcare provider to claim this additional funding. DAF is paid to the child's setting as a fixed annual rate. <https://www.gov.uk/disability-living-allowance-children/overview>

\* Early Years Pupil Premium (EYPP) is an additional sum of money paid to childcare providers for children of families in receipt of certain benefits. Please visit <https://www.gov.uk/get-extra-early-years-funding> for further information.
